3. COMPOSITION/INFORMATION ON CONSTITUENTS

Cocos Nucifera Wax is obtained from the hydrogenation of the fixed oil expressed from the kernels of the seeds of the Coconut, Cocos nucifera L., Palmaceae

Constituents:

Mixture of saturated vegetable Triglycerides C8– C18 and unsaturated C18. Other constituents are mono- and di-alkylglycerides, fatty acids and additional minor components that are inherently part of the vegetable oil composition.

4. FIRST AID MEASURES

- Ingestion:** Do not induce vomiting, give a glass of water. If unwell seek medical attention and show this information.
- Inhalation:** Remove casualty to fresh air, keep respiratory passages clear and seek medical attention.

7. HANDLING AND STORAGE

10. STABILITY AND REACTIVITY
